ORDINANCE NO. 484

AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the owners of all of the land hereinafter described, which is unplatted and does not exceed 200 acres, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have said land annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, a copy of said Petition was filed with the required governmental units and the Minnesota Municipal Commission, and

WHEREAS, no written objections to such annexation have been submitted to the Minnesota Municipal Commission or the City of White Bear Lake within the 30 day period required by Minnesota Statutes, and

WHEREAS, the City Council feels that such annexation will be to the best interest of the City of White Bear Lake and of the territory affected.

NOW, THEREFORE, the Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

The west one hundred feet (100) of the south two hundred sixty four (264) feet of Lot eight (8), Auditor's Subdivision No. 83, Ramsey Co., Minn., according to the plat thereof now on file and of record in the office of the Register of Deeds within and for said County and State, and including that part of Ninth Street adjacent to Lot 8.

2. That upon the effective date of this Ordinance such land shall become a part . of said City as if it has been originally a part thereof.

3. This Ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication, and after a copy of such is filed with the Ramsey County Auditor, Secretary of State for the State of Minnesota, and the Minnesota Municipal Commission.
