AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CFRTAIN LAND FORMERLY LOCATED IN THE TOWNSHIP OF HASSAN VALLEY - S. BUEHLER PROPERTY

THE CITY OF HUTCHINSON DOES ORDAIN:

SECTION 1. The following described property owned by S. Buehler is 60 per cent or more surrounded by the City of Hutchinson, MN:

Lot 9 of Auditor's Plat of Lot 15 of Auditor's Plat of Section 7 - T 116 N - R 29 W and Tract "B" of Registered Land Survey No. 1 in McLeod County, Minnesota

SECTION 11: Minnesota Statutes, Chapter 414.033, subdivison 3 provide as follows: "If the perimeter of the area to be annexed by a municipality is 60% or more bordered by the municipality, the municipality shall serve notice of intent to annex upon the Town Board. The Town Board shall have 60 days to serve objections with the Commission. If no objections are forthcoming within the 60 day period, such land may be annexed by ordinance. If objections are filed with the Commission, the Commission shall conduct hearings and issue its order as in the case of annexations under Section 10, subdivisions 3 and 4."

SECTION III. Notice having been served on the Town Supervisors of Hassan Valley Township, pursuant to Statute, on May 6, 1970, and no notice of objection being forthcoming in the prescribed 66 days, now therefore the City of Hutchinson, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota as effectually as if it had originally been a part thereof.

SECTION IV: This ordinance shall be final and shall take effect and be in force after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.

## Gentlemen:

The Hutchinson City Council, at its regular meeting of Monday, April 27, 1970 directed that notice of intent to annex the following described property be sent to the Hassan Valley Town Board:

Lot 9 of Auditor's Plat of Lot 15 of Auditor's Plat of Section 7 - T 116 N - R 29 W and Tract "B" of Registered Land Survey No. 1 in McLeod County, Minnesota

This property is 60 per cent or more bordered by the City of Hutchinson and we deem it to be urban in character and properly conditioned to be a part of the City of Hutchinson.

Minnesota Statutes Chapter 414.033, subdivision 3 provide as follows: "If the perimeter of the area to be annexed by a municipality is 60% or more bordered by the municipality, the municipality shall serve notice of intent to annex upon the Town Board. If objections are filed with the Commission, the Commission shall conduct hearings and issue its order as in the case of annexations under section 10, subdivisions 3 and 4."
