ORDINANCE NO. 22

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 21 ADOPTED SEPTEMBER 3, 1969, AND ENTITLED " AN ORDINANCE ANNEXING TO THE VILLAGE OF EYOTA, MINNESOTA, CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES IN AREA OF SECTION 11 OF TOWNSHIP 106 NORTH, RANGE 12 WEST, OLMSTED COUNTY, MINNESOTA. "

The Village Council of the Village of Eyota, Minnesota, do ordain:

Section 1: Section 1 of Ordinance No. 21 adopted September 3, 1969, and entitled "An Ordinance Annexing To The Village of Eyota, Minnesota, Certain Unplatted Lands Not Exceeding Two Hundred Acres In Area Of Section 11 Of Township 106 North, Range 12 West, Olmsted County, Minnesota. " is amended to include the following described lands located in Eyota Township, Olmsted County, Minnesota, to wit:

"All that portion of Lot Five (5) of the Rena-Belle Addition of Olmsted County, Eyota, Minnesota, lying in the Southwest Quarter (SW 1/4) of Section Eleven (11), Township One Hundred Six (106), Range Twelve (12)

Section 2. This Ordinance shall take effect and be in full force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

ORDINANCE NO. 21

AN ORDINANCE ANNEXING TO THE VILLAGE OF EYOTA, MINNESOTA, CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES IN AREA OF SECTION 11 OF TOWNSHIP 106 NORTH, RANGE 12 WEST, OLMSTED COUNTY, MINNESOTA.

The Village Council of the Village of Eyota, Minnesota, do ordain:

Section 1. A petition has been filed with the Village Council of the Village of Eyota, signed by all the owners of the land described herein, requesting the Village Council to annex said land to the Village of Eyota. The land described in said petition for annexation is located in Eyota Township, Olmsted County, Minnesota, and is described as follows:

All that part of Section Eleven (11), Township One Hundred Six (106), Range Twelve (12), Olmsted County, lying south and west of the RENA BELLE ADDITION of Olmsted County, Eyota, Minnesota.

All that part of Section Eleven (11), Township One Hundred Six (106), Range Twelve (12), Olmsted County, lying east of the RENA BELLE ADDITION of Olmsted County, Eyota, Minnesota, and south of U. S. #14.

Lot No. Seven (7) of the RENA BELLE ADDITION of Olmsted County, Eyota, Minnesota.

Lot No. Six (6) of the RENA BELLE ADDITION of Olmsted County, Eyota, Minnesota.

Containing approximately 31 Acres.

Said petition has also been filed with the Town Board of the Township of Eyota, with the County Board of the County of Olmsted and with the Municipal Commission of the State of Minnesota and more than thirty (30) days have elapsed since said petition was filed with said Town Board and County Board and no objections to annexation of the above described land have been filed by said Town Board or County Board.

Section 2. The quantity of unplatted land included in said petition is approximately 31 acres.

Section 3. The Village Council of the Village of Eyota does hereby determine that the land described in Section 1 abuts upon the present territorial limits of the Village of Eyota, is so conditioned as to be properly subjected to Municipal Government, and the annexation of said land will be in the best interests of the Village of Eyota and of the land affected.

Section 4. Therefore, the land described in Section 1 above is hereby annexed, added to and made a part of the Village of Eyota, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This Ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Passed and adopted by the Village Council of the Village of Eyota, Minnesota, this 3rd day of September, 1969.
