Ordinance No. 127

AN ORDINANCE TO AMEND THE CHARTER OF THE VILLAGE OF  
MAYER, CARVER COUNTY, MINNESOTA, BY  
ADDING A NEW SECTION

Whereas a petition dated October 23, 1969 as to the annexation of the territory described below was duly presented to the Council on the 23rd day of October, 1969;

and whereas it is shown that the said petition is proper and that no objections have been filed during the 60 day waiting period as prescribed by statute;

The Council of the Village of Mayer, Carver County, Minnesota, Ordinance

Section 1. It is hereby determined that the territory described below shall upon the Village and is so constituted as to be subject to Village Government.

Section 2. The corporate limits of the Village of Mayer are hereby extended to include the territory described as follows:  
Lots 1, 2, 3, 4, 5 and 6, Block 3, Pleasant Heights, according to the plat thereof on file and of record in the office of the Registrar of Deeds of Carver County, Minnesota.  
Lots 1, 2, 3, 4, 5 and 6, Block 3, Pleasant Heights, according to the plat thereof on file and of record in the office of the Registrar of Deeds of Carver County, Minnesota.  
Lots 1 and 2, Block 1, Pleasant Heights, according to the plat thereof on file and of record in the office of the Registrar of Deeds of Carver County, Minnesota,  
and also the above described property constitutes the entire plat of Pleasant Heights, Carver County, Minnesota and also includes Highway Ave., Cedar Ave., and Bayard Ave., being duly dedicated public streets as located upon said plat and also to include that part of State Highway Number 25 as the same abuts to the West of said property and as the same abuts upon the East of said Pleasant Heights.

Section 3. The Village Clerk is hereby directed to file certified copies of this Ordinance with the State of Minnesota Office of Commissioner, the Carver County Auditor, the Secretary of State of the State of Minnesota and the Town Clerk of Carver Township, Carver County, Minnesota.

Section 4. Amendments shall be made to said Ordinance from and after the date when certified copies of this Ordinance have been filed as directed in Section 3. above.
