AN ORDINANCE relating to the annexation of all that part of the Southeast Quarter, Section 2, Township 139, Range 45, described as follows: Beginning at a point where the West line of Bentley's First Addition to the Village of Hawley intersects the North line of the Southeast Quarter of Section 2, Township 139, Range 45; thence West along the North line of said Southeast Quarter of said Section 2 to the Northwest corner of said Southeast Quarter; thence South on the West line of said Southeast Quarter to the point of intersection with the North line of State Aid Road No. 3, now designated as County Road No. 116; thence Northeast along the North right-of-way line of said County Road No. 116; formerly State Aid Road No. 3, to the point of intersection with the West line of Thysell's Second Addition extended South; thence northwesterly along the West line of Thysell's Second Addition and the extension of said West line of Thysell's Second Addition to the Northwest corner of Thysell's Second Addition; thence northeasterly along the North line of Thysell's Second Addition to the Northeast corner of Thysell's Second Addition; thence southeasterly along the East line of Thysell's Second Addition to the Northwest corner of Work's First Addition to the Village of Hawley; thence northeasterly along the North line of said Work's First Addition to the Northeast corner of Lot 4, Block 2, Work's First Addition to the Village of Hawley; thence northwesterly to the Southwest corner of Lot 14, Block 1, Bentley's First Addition to the Village of Hawley; thence northwesterly and northerly along the West line of Bentley's First Addition to the point of beginning, situated in Clay County, Minn.

The Village Council of the Village of Hawley ordains as follows:

Sec. 1. The following described land owned by the Hawley Business Development Corporation, a corporation of the State of Minnesota, all of which is located in the County of Clay, State of Minnesota, is hereby added to, taken into, and made a part of the Village of Hawley, to wit:

All that part of the Southeast Quarter, Section 2, Township 139, Range 45, described as follows: Beginning at a point where the West line of Bentley's First Addition to the Village of Hawley intersects the North line of the Southeast Quarter of Section 2, Township 139, Range 45; thence West along the North line of said Southeast Quarter of said Section 2 to the Northwest corner of said Southeast Quarter; thence South on the West line of said Southeast Quarter to the point of intersection with the North line of State Aid Road No. 116, now designated as County Road No. 116; thence North east along the North right-of-way line of said County Road No. 116; formerly State Aid Road No. 3, to the point of intersection with the West line of Thysell's Second Addition extended south; thence northwesterly along the West line of Thysell's Second Addition and the extension of said West line of Thysell's Second Addition to the Northwest corner of Thysell's Second Addition; thence northeasterly along the North line of Thysell's Second Addition to the Northeast corner of Thysell's Second Addition; thence southeasterly along the East line of Thysell's Second Addition to the Northwest corner of Work's First Addition to the Village of Hawley; thence northeasterly along the North line of said Work's First Addition to the Northeast corner of Lot 4, Block 2, Work's First Addition to the Village of Hawley; thence northwesterly to the Southwest corner of Lot 14, Block 1, Bentley's First Addition to the Village of Hawley; thence northwesterly and northerly along the West line of Bentley's First Addition to the point of beginning.

Section 2. On this ordinance taking effect the corporate limits and boundary lines of the Village of Hawley shall be extended to include the northerly, westerly and southerly sides of said land.

Sec. 3. This ordinance shall take effect and be in force from and after its publication in the official newspaper.

Sec. 2. On this ordinance taking effect the corporate limits and boundary lines of the Village of Hawley shall be extended to include the northerly, westerly and southerly sides of said land.
