CHAPTER XV

ORDINANCE NO. 150 - C

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE UNINCORPORATED PROPERTY ABUTTING UPON THE VILLAGE LIMITS AND NOT EXCEEDING TWO HUNDRED ACRES IN AREA.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Village of Sartell on the 18th day of August, 1970; and,

WHEREAS, the quantity of land embraced within the area described in said Petition and bounded as described herein is not in excess of 200 acres of unplatted land, no part of which is included within the limits of an incorporated, City, Village or Borough; and,

WHEREAS, the Petition was signed by all of the owners of said land; and,

WHEREAS, no objection to the annexation has been received from the Town Board, the County Commissioners or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and,

WHEREAS the land described in the Petition abuts upon the Village Limits on the Easterly side thereof in Benton County, Minnesota; NOW, THEREFORE:

THE COUNCIL OF THE VILLAGE OF SARTELL, MINNESOTA, ORDAINS AS FOLLOWS:

Subsection 1. The Village Council hereby determines that the annexation will be to the best interest of the Village and of the territory affected; that the territory described herein abuts upon the Village Limits and is about to become urban or suburban in character; and, that none of said territory is now included within the limits of any incorporated City, Village or Borough.

Subsection 2. Territory Annexed. The corporate limits of the Village of Sartell are hereby extended to include the unplatted lands described as follows and the same are hereby annexed to and included within the Village as effectually as if it had originally been a part thereof, to-wit:

"The South Sixteen (S.16) Rds of the North Twenty-Four (N.24) Rds of the West Twenty (W.20) Rds of the Southwest Quarter of Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Ten (10), Township Thirty-Six (36), North of Range Thirty-One (31) West, Benton County, Minnesota, containing two acres."

Said Parcel being annexed by the Village of Sartell under Zoning Classification of R - 1.

Subsection 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Secretary of State, the Benton County Auditor, the Township of Brook Rapids and the Minnesota Municipal Commission.

Subsection 4. Effective Date of Amendment. This Ordinance will take effect upon the passage and publication and the filing of the certified copies as herein directed.
