Aug. 29, 1973 AMENDING AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY OWNED BY THE CIEY OF AUSTIN AND ABUTTING THEREON.

WHEREAS, this ordinance is to correct an error in the wording of the previous ordinance:

WHEREAS, the territory described below is not presently included within the corporate limits of any City, Village or Borough; and

WHEREAS, the City of Austin is the owner of the land described below and said premises adjoin the City of Austin and is deemed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1: The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows:

Commencing at the southwest corner of the southwest one quarter of Section 31, Township 103 North, Range 17 West, Mower County, Minnesota, thence north along the west line of said one quarter section a distance of 1,150 feet to the point of beginning, thence continuing north on the west line of said one guarter of section a distance of approximately553.4 feet, thence northeasterly at a deflection angle of 45011'32" to the right a distance of 1327.6 feet along the southeasterly line of outlot E in the Auditor's Plat of outlots in the west half of the west half of Section 31, Township 103 North, Range 17 West, recorded in Book 8 of Plats, page 3 as on file in the Register of Deeds Office, Mower County, Minnesota, thence at a deflection angle of 45039'12" to the right on the north line of said one quarter section to a point which is the center of said Section 31, thence south along the east line of said southwest one quarter of Section 31 to the southeast corner of said guarter section, thence west along the south line of said guarter section to a point 1,050 feet east of the southwest corner of said section, thence northerly on a line parallel to the west line of said guarter section a distance of 1150 feet, thence westerly on a line parallel to the south line of said quarter section a distance of 1050 feet to the point of beginning.

SECTION 2: The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, and the Township Clerk of Red Rock Township in which the property is located, and the Minnesota Municipal Commission.

SECTION 3: This ordinance takes effect upon passage and publication and filing certified copies as directed in Section 2.
