AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF GRAND RAPIDS TO INCLUDE UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE VILLAGE LIMITS AND ABUTTING THEREON.

Whereas, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough, and

Whereas, this territory is completely surrounded on all sides by lands already included within the corporate limits of the village and is deemed to be urban in character; the Village Council of the Village of Grand Rapids ordains:

SECTION 1. TERRITORY ANNEXED.

The corporate limits of the Village of Grand Rapids, Minnesota are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the village limits:

Government Lot One (1), Section Twenty-eight (28), Township Fifty-five (55), North, Range Twenty-five.

SECTION 2. FILING.

The Village Clerk is directed to file certified copies of this ordinance with the Secretary of State, County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

SECTION 3. EFFECTIVE DATE OF ANNEXATION.

This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
