AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE CITY OF MANKATO TO INCLUDE CERTAIN UNINCOR-
PORATED, UNPLATTED LAND, NOT EXCEEDING TWO
HUNDRED ACRES, ABUTTING UPON THE CITY LIMITS.

WHEREAS, A petition has been duly filed and presented to the
City Council, requesting annexation of the territory hereinafter des-
cribed; and

WHEREAS, The quantity of land embraced within the areas
described in the petition does not exceed 200 acres, and abuts upon
the City limits at the easterly boundary thereof, no part of which is
included within the limits of an incorporated city, village or burough;
and

WHEREAS, The petition was signed by the following owners
thereof: Cy St. Peter, Mary St. Peter and Lloyd's Eastwood Manor, Inc.;
and

WHEREAS, No objections to the annexation have been received
from the Town Board, the County Board, or the governing body of any
municipality whose boundaries abut the land to be annexed;

The City of Mankato, Minnesota does ordain:

1. The annexation will be to the best interests of the City
and of the land affected;
2. The land described herein abuts upon the City limits and
is urban in character;
3. None of the land is now included within the limits of
any city, village or burough.

The corporate limits of the City are hereby extended to in-
clude the land described as follows and the same is hereby annexed to
and included within the City as effectually as if it had originally
been a part thereof:

West 2 acres of the East $7\frac{1}{2}$ acres of the North $\frac{1}{2}$ of the
Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 16, Township
108 North, Range 26 West; and the South $\frac{1}{2}$ of the North
40 rods of the East 22 rods of the Southwest $\frac{1}{4}$ of the
Southwest $\frac{1}{4}$ of Section 16, Township 108 North, Range 26
West, Blue Earth County, Minnesota.

The City Clerk is hereby directed to file certified copies
of this ordinance with the Minnesota Municipal Commission, the Secretary
of State and the County Auditor. This ordinance shall take effect ten
(10) days after the date of its passage and publication and the filing
of certified copies as directed.


