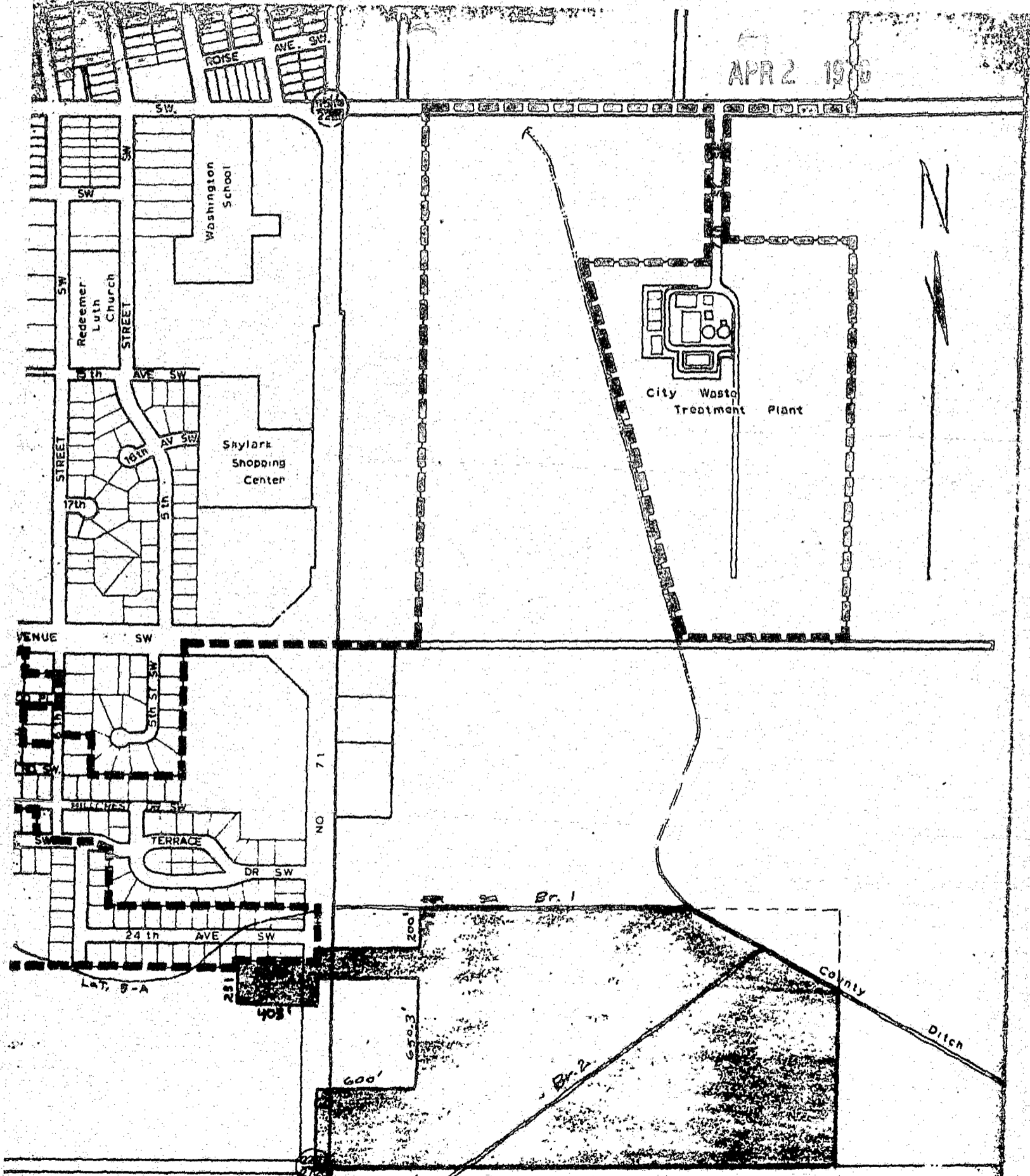

The West 600 feet of the South 650.3 feet of the North 993.3 feet of the Southwest Quarter of the Southwest Quarter of Section 23; and


That part of the South half of the SW $\frac{1}{4}$  of Section 23 which lies North and East of the centerline of Co. Ditch 23-A.
