ORDINANCE NO. 59

AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF HAMBURG, MINNESOTA AND INCORPORATE ADDITIONAL TERRITORY THEREIN.

WHEREAS, the Village of Hamburg has previously purchased the land hereinafter described and is the owner thereof; and

WHEREAS, Minnesota Statute Section 414.033 provides that land which are owned by a municipality may be annexed by Ordinance without further proceedings,

THE VILLAGE COUNCIL OF THE VILLAGE OF HAMBURG, CARVER COUNTY, MINNESOTA, DO ORDAIN:

Section I.

DECLARATION. It is hereby determined that the territory described below abuts the present corporate limits of the Village of Hamburg; that said lands are not now included in any other municipality; that said lands are urban in character; and that said lands are owned by the Village of Hamburg.

Section II.

TERRITORY ANNEXED. The corporate limits of the Village of Hamburg are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

Commencing at a point ten (10) rods west of the intersection of the north boundary line of the public highway running east and west along the south line of Section Twenty-nine (29), Township One Hundred Fifteen (115), Range Twenty-six (26) with the east line of said Section Twenty-nine (29), thence South to the centerline of said east and west highway; thence due west along the centerline of said public highway a distance of eighteen (18) rods to a point; thence due north to the north boundary of said public highway, thence continuing due north and parallel with the east line of said Section Twenty-nine (29) a distance of eighteen (18) rods to a point, thence due east and parallel with said north boundary line of said public highway a distance of eighteen (18) rods to a point and thence due south and parallel with the east line of said Section Twenty-nine (29) a distance of eighteen (18) rods to the place of beginning.

Section III.

FILING. The Village Clerk is hereby instructed to file certified copies of this Ordinance with the Municipal Commission of the State of Minnesota, Secretary of State, and the Auditor of Carver County.

SECTION IV.

EFFECTIVE DATE OF ANNEXATION. Annexation shall be deemed final upon the filing of the certified copies as directed in Section III.
