VILLAGE OF PRESTON, MINNESOTA

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE VILLAGE OF PRESTON,  
MINNESOTA

THE VILLAGE COUNCIL OF THE VILLAGE OF PRESTON ORDAINS:

Section 1. The following described land situated in the County of Fillmore, State of Minnesota, shall be and hereby is annexed to the Village of Preston, Minnesota:

The northwest quarter of Section 7, Township 102 north of Range 10 west, except the following described two parcels:

PARCEL I: Commencing at the southwest corner of the northwest quarter of said Section 7, thence east on the south line of said quarter section 80 rods, thence north 30 rods, thence west parallel to the south line of said quarter section 80 rods, thence south 30 rods to the place of beginning.

PARCEL II: Commencing at the southeast corner of said northwest quarter of said Section 7, thence north 18 8/9ths rods, thence west 18 rods, thence south 18 8/9ths rods, thence east 18 rods to place of beginning.

The northeast quarter of the northeast quarter of Section 12, Township 102 north of Range 11 west, except the following described parcel:

Beginning in the center of the County State Aid Highway No. 15 on the west line of said northeast quarter of the northeast quarter of Section 12, distant 397 feet north of the southwest corner thereof, thence running northeasterly along the center line of said public road at an angle of 40 degrees 48 minute with said west line for 891 feet to a point 230 feet south and 730 feet west of the northeast corner of Section 12, thence running northwesterly to the northwest corner of the northeast quarter of the northeast quarter of Section 12, thence running southerly along the west line of the northeast quarter of the northeast quarter of said Section 12 to the point of beginning and there terminating.

Section 2. It is hereby determined and declared that said annexation is in the best interests of the Village of Preston and of the said territory hereby annexed.

Section 3. This ordinance is passed pursuant to the provisions of Minnesota Statutes, Sec. 414.033, subd. 5.

Section 4. This ordinance shall take effect from and after the 31st day of December, 1970.
