ORDINANCE NO. 1971-A

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ST. JOSEPH TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LANDS NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain Petition dated October 19, 1970 requesting annexation of the territory hereinafter described was duly presented to the Council on the 19th day of October, 1970; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is 72.01 acres of unplatted land, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the Petition was signed by all of the owners of said tract; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of that land to be annexed; and

WHEREAS, the land described in the Petition abutts upon the Village limits at the Northeastly boundary thereof;

THE COUNCIL OF THE VILLAGE OF ST. JOSEPH, MINNESOTA, ORDAINS:

Section 1. The Village Council hereby determines

(a) That the Annexation will be to the best interests of the Village and of the territory affected;

(b) That the territory described therein abutts upon the Village limits and is about to become urban or sub-urban in character;

(c) That none of said territory is now included within the limits of any City, Village, or borough.

Section 2. The corporate limits of the Village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof;

The Northwest Quarter of the Northeast Quarter ($NE\frac{1}{4}NW\frac{1}{4}$) and the Northeast Quarter of the Northwest Quarter ($NE\frac{1}{4}NW\frac{1}{4}$) of Section Ten (10), Township One Hundred Twenty Four (124), Range Twenty Nine (29), Stearns County, Minnesota, except the West Two Hundred Sixty Four (264) feet of the Northeast Quarter of the Northwest Quarter ($NE\frac{1}{4}NW\frac{1}{4}$); also the South Ninety Nine (99) feet of the West Two Hundred Sixty Four (264) feet of the Northeast Quarter of the Northwest Quarter ($NE\frac{1}{4}NW\frac{1}{4}$); also the North Six and Eight Tenths (6.8) feet of the West Two Hundred Sixty Four (264) feet of the Northeast Quarter of the Northwest Quarter of said Section Ten (10) except that part of Lot Twelve (12) of Auditor's Sub-division No. 4 which is already part of the Village of St. Joseph.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor, and the Register of Deeds.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
