AN ORDINANCE EXTENDING THE COPPOPATE LIMITS OF THE CITY OF BENSON TO INCLUDE UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated September 15. 1970, requesting annexation of the property hereinafter described was duly presented to the council on the _/7_day of _September______, 1970; and WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 8.06 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all owners; and
WHEREAS, no objections to the annexation have been received from
the town board, the county board or the governing body of any
municipality whose boundaries abut upon the boundaries of the land
to be annexed;

WHEREAS, the land described in the petition abuts upon the city limits at the Easterly boundary thereon at the Northerly end thereof; The Council of the City of Benson, Minnesota, ordains:

Section 1. The City council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

All land lying and being in the County of Swift, State of Minnesota, described as follows, to-wit: Part of the Southwest Quarter of the Northeast Quarter (SW*-NE*) of Section Five (5), Township One Hundred Twenty-one (121), Range Thirty-nine (39), described as follows: Commencing at the SW corner of the NE* of Sec. 5, Twp. 121, Pange 39, thence Nlv on the W line of said NE* of Sec. 5, bearing N 0°00' E for 350 feet to a point which will be called the point of beginning thence Ely, bearing S 88°9½' E for 1036.2 feet; thence Slv, bearing S 0°00 E for 350 feet; thence Ely, bearing Elv, bearing S 88°9½' E for 259.8 feet; to the SE corner of the SW* of the NE* of said Sec. 5; thence Nlv on the E line of said SW* of the NE* of

Sec. 5, bearing N 0°34%' E for 579.9 feet; thence Wlv, bearing N 90°00' W for 1031.2 feet; thence Slv. bearing S 0°00' W for 80 feet; thence Wlv. bearing S 90°00' W for 128.2 feet to the point of beginning, cont. 8.06 acres.

Section 3. Filing. The City clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4. Upon annexation, all of the above described real estate shall be and is hereby included in the "R-2" Multiple Dwelling Zoning District.

Section 5. That the boundaries of the zoning map of Benson, Minnesota, be amended and changed to include all of the property above described, and that the applicable changes be made to reflect the districting above described.

Section 6. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
