ORDINANCE NO. 19-10  
4

5 AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF BUFFALO TO  
6 INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE VILLAGE LIMITS.

7 WHEREAS, a certain petition dated September 2, 1970, requesting annexation  
8 of the territory hereinafter described was duly presented to the council on the  
9 5th day of October, 1970; and

10 WHEREAS, the quantity of land embraced within the area described in the  
11 petition and bounded as described is one-half acre of platted land, no part of  
12 which is included within the limits of an incorporated city, village, or borough;  
13 and

14 WHEREAS, the petition was signed by all owners; and

15 WHEREAS, no objections to the annexation have been received from the town  
16 board, the county board, or the governing body of any municipality whose bound-  
17 aries abut upon the boundaries of the land to be annexed; and

18 WHEREAS, the land described in the petition abuts upon the village limits  
19 at the northern boundary thereof; The council of the Village of Buffalo, Minnesota,  
20 ordains:

21 Section 1 The Village council hereby determines (1) that the annexation  
22 will be to the best interests of the village and of the territory affected;  
23 (2) that the territory described herein abuts upon the village limits and is  
24 urban or suburban in character; and (3) that none of said territory is now  
25 included within the limits of any city, village, or borough.

26 Section 2 Territory Annexed. The corporate limits of the village are  
27 hereby extended to include the platted land described as follows and the same is  
28 hereby annexed to and included within the village as effectually as if it had  
29 originally been a part thereof;

30 The South Two Hundred and Fifteen feet of Lot One in Lot "D" of the West  
31 Half ( $\frac{1}{2}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Twenty, in Township One  
32 Hundred Twenty, of Range Twenty-five, containing One-half acre, more or less,  
33 according to the plat on file and of record in the Office of the Register of  
34 Deeds in and for said Wright County, Minnesota, also that portion of public road  
35 abutting on the South side thereof.

36 Section 3 Filing. The village clerk is hereby directed to file certified  
37 copies of this ordinance with the Minnesota Municipal Commission, the Secretary

1 of State, and the County Auditor.

2       Section 4. Effective Date. This ordinance takes effect upon its passage  
3 and publication and the filing of the certified copies as directed in Section 3.
