ORDINANCE NO. 588
AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF RED WING, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the council of the City of Red Wing on the 2nd day of July, 1970; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 170 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all of the owners of the said land; and

WHEREAS, copies of the petition were duly filed with the Town Board of Hay Creek Township, the County Board of Goodhue County, and the Municipal Commission; and

WHEREAS, no objections to the annexation have been received from the town board or the county board; and

WHEREAS, the land described in the petition abuts upon the city limits at the southerly boundary thereof; and

WHEREAS, more than 60 days have elapsed since the filing of the said petition with the City of Red Wing, the Town Board, the County Board, and the Municipal Commission;

NOW THEREFORE THE CITY COUNCIL OF THE CITY OF RED WING DO ORDAIN:

SECTION 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Red Wing and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

SECTION 2. TERRITORY ANNEXED. The corporate limits of the City of Red Wing are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City of Red Wing as effectually as if it had originally been a part thereof:

Northeast quarter (NE1/4) of Section 6, Township 112 North, Range 14 West, County of Goodhue, State of Minnesota.

SECTION 3. FILING. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Town Clerk of Hay Creek Township, the County Auditor, and the Secretary of State.

SECTION 4. EFFECTIVE DATE. This ordinance shall take effect thirty days after publication and upon filing of the certified copies as directed in Section 3.

(6) Said newspaper files a copy of each issue immediately with the State Historical Society.

(7) Said newspaper has complied with all the foregoing conditions for at least two years preceding the day or dates of publication mentioned below.

(8) Said newspaper has filed with the Secretary of State of Minnesota prior to January 1, 1968, and each January 1 thereafter an affidavit, in the form prescribed by the Secretary of State and signed by the managing officer of said newspaper and sworn to before a notary public stating that the newspaper is a legal newspaper.
