ORDINANCE NO. 331

THE CITY OF MORRIS DOETH ORDAIN:

Section 1. The City of Morris does hereby, by consent and agreement of the property owners involved, annex to and cause to become and form a part of, the City of Morris, Minnesota, the premises in the County of Stevens, State of Minnesota, described as follows:

Lot Five (5), County Subdivision of the West Half of the Southwest Quarter ($W\frac{1}{2}SW\frac{1}{4}$) of Section Two (2), Township One Hundred Twenty-four (124) North, Range Forty-two (42) West, Stevens County, Minnesota, excepting therefrom the following described parcel:

Beginning at a point which is 895' feet South of the Northwest corner of the Southwest Quarter of Section 2, Township 124 North, Range 42 West and Easterly on a bearing of North $89^{\circ}10'$ East a distance of 75.65' to the East Right of way line of T. H. #59, thence continuing Easterly on a bearing of North $89^{\circ}10'$ East a distance of 350 feet; thence on a bearing of North $00^{\circ}46'$ West a distance of 429.08 feet; thence on a bearing of South $89^{\circ}19'$ West a distance of 350 feet to a point on the East R/W line of T. H. #59; thence Southernly along the East R/W line of said T. H. #59 R/W line a distance of 430 feet to the point of beginning and there terminating.
