



AN ORDINANCE INCORPORATING CERTAIN LANDS SURROUNDED BY THE
CITY OF HUTCHINSON, MINNESOTA AND FORMERLY LOCATED IN THE
TOWNSHIP OF LYNN.

THE CITY OF HUTCHINSON DOES ORDAIN:

Section I. The following described property owned by S. P. Steffenson, Alvina Steffenson; Orville I. Lund and Edna A. Lund is completely surrounded by the City of Hutchinson, Minnesota:

Beginning at the Northeast corner of Section 12, Township 116 North, Range 30 West; thence Southerly along the East Line of said Section 12, a distance of 350.0 feet; thence Westerly on a line parallel with the North line of said Section 12, a distance of 200.0 feet; thence Northly on a line parallel with said East line a distance of 155.0 feet; thence Westerly on a line parallel with said North line, a distance of 245.0 feet; thence Northerly on a line parallel with said East line, a distance of 195.0 feet; thence Easterly along said North line, a distance of 445.0 feet to the point of beginning. - S. P. Steffenson property.


Beginning at a point 350.0 feet South of the Northeast corner of the Northeast Quarter of Section 12, Township 116 North, Range 30 West; thence Westerly on a line parallel with the North line of Section 12 a distance of 200.0 feet; thence Southerly on a line parallel with the East line of Section 12 a distance of 260.0 feet; thence Easterly on a line parallel with said North line, a distance of 200.0 feet to a point on said East line; thence Northerly along said East line, a distance of 260.0 feet to the point of beginning. - O. Lund Property.


Section II. MSA, Section 414.033, Subdivision 4 provides that "If the land is completely surrounded by land within the municipal limits, the municipal council may by ordinance declare the land annexed to the municipality, and any such land is deemed to be urban in character."

Section III. Therefore, the City of Hutchinson, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota as effectually as if it had originally been a part thereof.

Section IV. This ordinance shall be final and shall take effect and be in force after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
