ORDINANCE NO. 227

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENCOE TO INCLUDE CERTAIN UNINCORPORATED PROPERTY ABUTTING UPON THE CORPORATE LIMITS OF SAID CITY.

THE CITY COUNCIL OF THE CITY OF GLENCOE ORDAINS:

1. That the corporate limits of the City of Glencoe be and they hereby are extended to include the following described real estate, abutting on the corporate limits of said city, and described as follows to-wit:

All that part of the Northwest Quarter of Section Eighteen, Township One Hundred Fifteen, Range Twenty-seven West, described as: Beginning at the intersection of the North Right of Way line of Truck Highway No. 212 and the North and South Quarter line of Section Eighteen, Township One Hundred Fifteen, Range Twenty-seven West, said point being 456.50 feet North of the center of said Section Eighteen; thence on a bearing of North 89° 42' East along said North Highway Right of Way line for 1055.70 feet; thence on a tangential curve concave to the South along said North Highway Right of Way line for 1325.60 feet more or less to a point on a line which bears South 57° 16' East and distance 163.30 feet from a point on the West line of said Northwest Quarter, said point being 293.60 feet North 0° 14' West from the Southwest corner of said Northwest Quarter; thence on a bearing of North 57° 16' West for a distance of 163.30 feet to a point on the West line of said Northwest Quarter, said point being 293.60 feet North 0° 14' West from the Southwest corner of said Northwest Quarter; thence on a bearing of North 0° 14' West along the said West line of the Northwest Quarter for a distance of 419.40 feet to the intersection with the Easterly extension of the South line of Eleventh Street in the City of Glencoe, Minnesota, thence on a bearing of North 89° 19' East along the said Easterly Extension of the South line of Eleventh Street for a distance of 2001.00 feet; thence on a bearing of North 0° 00' West parallel with the said East line of the Northwest Quarter for a distance of 787.40 feet to a point on the Southerly right of way line of the Chicago, Milwaukee, St. Paul & Pacific Railway; thence on a bearing of North 85° 37' East along said Southerly right of way line for a distance of 690.12 feet to a point on the said East line of the Northwest Quarter; thence on a bearing of South 0° 00' East along said East line of the Northwest Quarter for a distance of 1151.70 feet to the point of beginning.

2. This ordinance takes effect from and after its passage and publication.

Adopted and approved by the Council this 16th day of November, 1970.




