ORDINANCE NO. 228

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENCOE TO INCLUDE CERTAIN UNINCORPORATED PROPERTY ABUTTING UPON THE CORPORATE LIMITS OF SAID CITY.

THE CITY COUNCIL OF THE CITY OF GLENCOE ORDAINS:

1. That the corporate limits of the City of Glencoe be and they hereby are extended to include the following described real estate, abutting on the corporate limits of said city, and described as follows to-wit:

Commencing at the Northeast Corner of the Southeast Quarter of Section 13 Township 115 North Range 28 West; thence on a bearing of South 89°59'51" West along the North line of said Southeast Quarter, also being the South line of Ninth Street in the City of Glencoe, Minnesota, for a distance of 383.33 feet to the actual point of beginning of the following described tract; thence continuing on a bearing of South 89°59'51" West along the said North line of Southeast Quarter and South line of Ninth Street for a distance of 664.67 feet to an iron monument in place; thence on a bearing of South 0°00' West for a distance of 233.38 feet to a point on a curve, radius of 2757.71 feet, whose center of radius bears North 9°20'45" West, said curve being the northerly right of way line of proposed T.H. 212, said point being distant 100.00 feet, measured at right angles, from the centerline of the proposed West bound lane of T.H. 212; thence Northeasterly along curve an arc length of 621.91 feet, central angle 12°55'16", to point of spiral curve; thence along spiral curve of uniformly decreasing degree of curvature a distance of 73.06 feet; thence on a bearing of North 0°00' East for a distance of 32.73 feet to the point of beginning.

2. This ordinance takes effect from and after its passage and publication.
