THE VILLAGE COUNCIL OF KENNEDY ORDAINS:

Section 1. That the following property shall be annexed  
pursuant to M.S.A. 414.033 to the Village of Kennedy, Minnesota:

That portion of the Northeast one-quarter (NE $\frac{1}{4}$ )  
and the Southeast one-quarter (SE $\frac{1}{4}$ ) of Section  
Twenty-five (25), Township One Hundred Sixty  
(160) North, Range Forty-nine (49) West, lying  
south of the North Section line of Section 25, west  
of the right of way of Trunk Highway No. 75 as  
now located and east of the right of way of the  
Great Northern Railroad, presently known as the  
Burlington Northern, Inc., and north of the Village  
limits of the Village of Kennedy AND the South 100  
feet of the right of way of the Great Northern Railroad,  
presently known as Burlington Northern, Inc., lo-  
cated in the Northeast one-quarter of the Southeast  
one-quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section 25, Township 160  
North, Range 49 West.

Section 2. That it will be to the best interests of the  
Village of Kennedy, Minnesota, and the Territory affected that such  
land be annexed to the Village of Kennedy, Minnesota.

Section 3. That said annexation shall be effective upon  
the publication of this Ordinance.
