ORDINANCE NO. 189 - 8

ORDINANCE NO. 189 - 8

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE UNINCORPORATED PROPERTY ADJACENT UPON THE VILLAGE LIMITS AND NOT EXCEEDING 200 ACRES IN AREA. WHEREAS a certain petition requesting annexation of the territory hereinafter described was duly presented to the Village of Sartell on the 24th day of November, 1970; and, WHEREAS the quantity of land embraced within the area described in said Petition and bounded as described herein is not in excess of 200 acres of platted land, no part of which is included within the limits of an incorporated city, village or borough; and, WHEREAS the petition was signed by all of the owners of said land; and, WHEREAS no objection to the annexation has been received from the Town Board, the Benton County Commissioners or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be herein annexed; and,

WHEREAS the land described in the Petition abuts upon the Village Limits on the South-
only boundary thereof in Benton County, Minnesota; and, WHEREAS:

THE COUNCIL OF THE VILLAGE OF SARTELL, MINNESOTA, ORDAINS AS FOLLOWS:

Section 1. The Village Council hereby determines that the annexation will be to the best interest of the Village and of the territory affected; that the territory described herein abuts upon the Village Limits and is about to become urban or suburban in character; and that none of said territory is now included within the limits of any incorporated city, village or borough.

Section 2. Territory Annexed. The corporate limits of the Village of Sartell are hereby extended to include the platted land described as follows and the same are hereby annexed to and included within the Village as effectually as if it had originally been a part thereof, to-wit:

"LOT ONE (1), BLOCK ONE (1) of WASHINGTON TRAIL ADDITION, excepting therefrom the East 69.20 Feet thereof, according to the Plat and Survey thereof on file and of record in the Office of the Register of Deeds in and for Benton County, Minnesota."

Said property being annexed under Village Zoning Classification of R - 1

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Secretary of State, Benton County Auditor, Township of Oak Rapids and the Minnesota Municipal Commission.

Section 4. Effective Date of Annexation. This Ordinance will take effect upon the passage and publication and filing of the certified copies as herein directed.
