# 71-402

AN ORDINANCE EXTENDING THE CORPORATE  
LIMITS OF THE CITY OF MANKATO TO  
INCLUDE CERTAIN UNINCORPORATED UNPLATTED  
LAND NOT EXCEEDING TWO HUNDRED ACRES  
ABUTTING UPON THE CITY LIMITS.

WHEREAS, a petition has been duly filed and presented to the Council, requesting annexation of the territory hereinafter described; and

WHEREAS, the quantity of land embraced within the area described in the petition does not exceed 200 acres, and abuts upon the City Limits at the easterly boundary thereof, no part of which is included within the limits of an incorporated, city, village, or burough; and

WHEREAS, the petition was signed by the owners Lyle Reisenbigler, and Rachel Reisenbigler, husband and wife and George Kroenke, and Jane Kroenke, husband and wife; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed.

The City of Mankato, Minnesota, does ordain:

1. That the annexation will be to the best interests of the City and of the land affected;
2. That the land described herein abuts upon the City Limits and is urban in character; and
3. That none of said land is now included within the limits of any city, village, or burough.

The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

The east half (E $\frac{1}{2}$ ) of the northwest quarter (NW $\frac{1}{4}$ ) of the northwest quarter (NW $\frac{1}{4}$ ) of the southeast quarter (SE $\frac{1}{4}$ ) of Section 8, Township 108, Range 26, Blue Earth County, except the north 455 feet, thereof, containing 1.56 acres more or less.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor. This Ordinance shall take effect ten days after the date of its passage and publication.
