ORDINANCE NO. 431

**AN ORDINANCE EXTENDING
THE CORPORATE LIMITS OF
THE CITY OF CROOKSTON
TO INCLUDE CERTAIN UNIN-
CORPORATED AND UNPLAT-
ED LAND NOT EXCEEDING
200 ACRES IN AREA, ABUT-
TING UPON THE CITY.**

WHEREAS, a certain petition, dated July 27th, 1970, requesting annexation of the territory hereinafter described, was duly presented to the Council on the 28th day of July, 1970; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described, is 25.13 acres, more or less, of unplatted land, no part of which is included within the limits of an incorporated City, Village or Borough; and

WHEREAS no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS the land described in the Petition abuts upon the City limits at the northern boundary thereof;

NOW THEREFORE, BE IT ORDAINED by the City of Crookston as follows:

Section 1: The City Council hereby determines

11-13-70

(1) That the annexation will be to the best interests of the City and of the territory affected;

(2) That the territory described herein abuts upon the City limits and is, or is about to become, urban or suburban in character, and

(3) That none of said territory is now included within the limits of any City, Village or Borough.

Section 2. TERRITORY ANNEXED: The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City, as effectually as if it had originally been a part thereof:

That part of the Southeast quarter of the Southeast quarter (p't SE 1/4 SE 1/4), of Section Twenty-four (24), Township One Hundred Fifty (150), North of Range Forty-seven (47), West of the Fifth Principal Meridian, in Polk County, Minnesota, described as:

Commencing at the Southeast corner of said Section 24; thence Westerly along the South section line 888 feet; thence Northerly parallel to the East section line 1233 feet; thence Easterly 888 feet to the East section line; thence Southerly 1233 feet to the point of beginning, containing 25.13 acres, more or less, according to the United States Government survey thereof.

Section 3. FILING: The City

Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor of Polk County, Minnesota.

Section 4. **EFFECTIVE DATE:** This Ordinance takes effect upon its passage and publication and pursuant to the Municipal Charter of the City of Crookston, and the filing of the certified copies as directed in Section 3. thereof.

Adopted by the Council this 10th day of November, 1970.
