ORDINANCE NO. 161

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LANDS.

The City Council of the City of Worthington do Ordain:

Section 1. Petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following real estate, to have such property included within the City of Worthington, Minnesota:

That part of Section 14, Township 102, Range 40, described as commencing 1105 feet east of the southeast corner of Section 14; thence northwesterly at an angle of  $70^{\circ} 19'$  west, 320 feet; thence east parallel with the south section line, a distance of 107.4 feet; thence southeasterly 320 feet to a point on the south section line which point is 107.4 feet east of the point of beginning; thence west on the south section line, a distance of 107.4 feet to the point of beginning, subject to highway easements and also subject to an easement for travel to the Standard Oil Company over the easterly 120 foot thereof. Also a permanent easement across the easterly 120 feet of that property lying adjacent to and within 70 feet east of the easterly boundary of the above described property, subject to highway easements,

but excepting therefrom

That part of the Southwest Quarter (SW 1/4) of Section 14, Township 102 North, Range 40 West, Nobles County, Minnesota, described and bounded as follows: Commencing at the southeast corner of said Section 14, thence north  $90^{\circ} 00'$  east (assumed bearing) for 1,100.00 feet, thence north  $19^{\circ} 11'$  west for 240.00 feet to the point of beginning, thence north  $19^{\circ} 11'$  west for 60.00 feet, thence north  $90^{\circ} 00'$  east for 25.00 feet, thence south  $60^{\circ} 59'$  east for 75.76 feet to the true point of beginning, containing an area of 0.02 acres more or less,

and

That part of the Southwest Quarter (SW 1/4) of Section 14, Township 102 North, Range 40 West, Nobles County, Minnesota, described and bounded as follows: Commencing at the southeast corner of said Section 14, thence north  $90^{\circ} 00'$  east (assumed bearing) for 1100.00 feet, thence north  $19^{\circ} 11'$  west for 160.00 feet to the point of beginning, thence north  $19^{\circ} 11'$  west for 60.00 feet, thence south  $60^{\circ} 59'$  east for 75.76 feet, thence north  $90^{\circ} 00'$  east for 25.00 feet to the true point of beginning, containing an area of 0.02 acres more or less.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 0.8 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on November 20, 1970, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Page 2 -- Ordinance No. 461

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein shall upon the City and in as conditioned as property to be subjected to city government.

Section 5. The corporate limits of the City are hereby extended to include the property described in Section 4, and the same is hereby annexed to, and included in the City as effectively as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon filing of the certified copies as directed in Section 6.
