ORDINANCE NO. 362 AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do hereby ordain as follows:

Section 1.

WHEREAS the following described property situated in the County of Pennington and State of Minnesota, to-wit:

A parcel of land which is part of Gov't Lot 3, T.153N, R.43W bounded as follows:

Beginning at a point on the West line of said Gov't. Lot 3 which point lies 133' South of the North line of said Gov't. Lot 3; thence East salong a line parallel to the North line of said Gov't. Lot 3 a distance of 169'; thence South along a line parallel to the West line of Tindolph Avenue a distance of 78'; then ce East along a line parallel to the North line of said Govt. Lot 3 a distance of 169' to the west line of Tindolph Ave.; thence South along said West line a distance of 176'; thence West along a line parallel to the North line of said Gov't. Lot 3 a distance of 169'; thence South along a line parallel to the West line of Tindolph Avenue a distance of 129'; thence West along a line parallel to the said Gov't. Lot 3; thence North along said West line a distance of 383; to the North line of said Gov't. Lot 3 a distance of 169' to the West line of said Gov't. Lot 3; thence North along said West line a distance of 383; to the point of beginning; containing 2.2 acres more or less,

is completely surrounded by land within the municipal limits.

NOW, THEREFORE, pursuant to M.S.A. 414.033, Subd. 4 the above described property is hereby declared to be incorporated within and annexed to the City of Thief River Falls, Minnesota.

Section 2.

This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Commission, the Pennington County Auditor and the Secretary of State of the State of Minnesota.
