ORDINANCE NO. 510
AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the perimeter of the land herein after described is one hundred (100) percent bordered by the City of White Bear Lake, and

WHEREAS, the City Council feels that such annexation will be to the best interest of the City of White Bear Lake and the territory affected.

NOW, THEREFORE, The Council of the City of White Bear Lake, Minnesota does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

All that part of the lands and rights-of-way of and for Interstate Highway Numbered 1-694 lying in the Southeast quarter of Section 35, Township 30 north, Range 22 west and not presently within the corporate limits of the City of White Bear Lake, as recorded in the office of the Register of Deeds of and for the County of Ramsey, Minnesota, under Commissioner of Highways definite location order no. 37217 and width order numbers 37218 and 43451.

2. That upon the effective date of this Ordinance such land shall become a part of said City as if it has been originally a part thereof.

3. This Ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication, and after a copy of such is filed with the Ramsey County Auditor, Secretary of State for the State of Minnesota, and the Minnesota Municipal Commission.

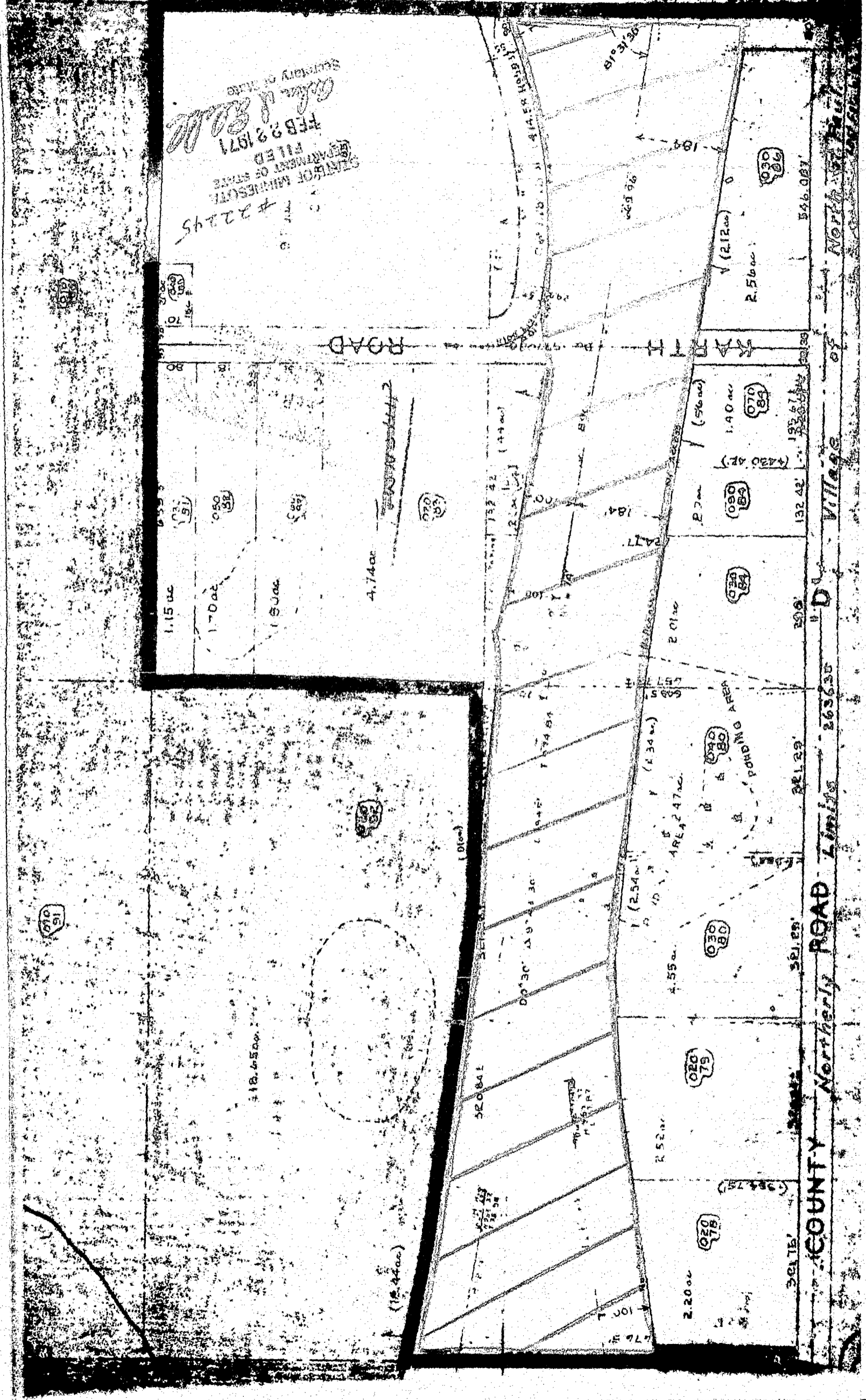
