AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SAUK RAPIDS TO INCLUDE CERTAIN PLATTED PORTIONS OF OAKRIDGE THIRD ADDITION, BENTON COUNTY, MINNESOTA.

The Village Council of the Village of Sauk Rapids, Minnesota, hereby amends Section 15 of the official Code of Ordinances by the addition of the following section, to-wit:

## Section 15.

(1) The Governing body of the Village of Sauk Rapids, Minnesota, resolves to have the following land included within the Village of Sauk Rapids, Minnesota:

Lots Five (5) and Six (6), Block Four (4) and Lot Twenty-four (24), Block Three (3) all in Oakridge Third Addition, Benton County, Minnesota, and in addition thereto, all full abutting roadways and roadways within the perimeter of said parcel of land, except for Minnesota Trunk Highway # 10,

- (2) The quantity of land embraced within the foregoing description is unincorporated land abutting on the Village of Sauk Rapids, and is not included in anyother municipality, and does not border any other municipality and is platted land less than 200 acres.
- (3) The Village Council hereby determines:
  - a. That the annexation of said above described tract will be to the best interest of the Village of Sauk Rapids, and the territory affected.
  - b. That the territory described herein abuts upon the village and is so conditioned as properly to be subjected to village governments.
  - c. That a petition requesting such annexation has been received from all owners of said territory;
  - d. That said territory is presently within the limits of the town of Sauk Rapids, which town has consented in writing to said annexation.

e. That said territory is within Benton County, Minnesota, and that the County Board of said County was duly notified of of the proposed annexation and that no objection has been received from said Benton County, although more than thirty (30) days have elapsed since said notice.

- (4) That the property hereinbefore described be, and the same hereby is, annexed to, included in, the Village of Sauk Rapids, Minnesota, as effectfually as if it had originally been a part thereof and that upon annexation shall be zoned as follows:
  - a. Lot Five (5), Block Four (4), Oakridge Third Addition will be zoned R-2;
  - b. Lot Six (6), Block Four (4), Oakridge Third Addition will be zoned R-3;
  - c. Lot Twenty-four (24), Block Three (3), Oakridge Third Addition will be unclassified as Church property.
- (5) This ordinance shall be final and shall take effect and be in force from and after filing of certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State, and from and after its passage and publication.
