ORDINANCE NO. 358

5-26-70

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LITCHFIELD, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated 2-26-70, requesting annexation of the territory hereinafter described was duly presented to the council on the 5th day of April, 1970; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is eighty (80) acres of unplatte land, no part of which is included within the limits of an unincorporated city, village, or borough; and

WHEREAS, the petition was signed by all and the only sole owner of said land and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the East boundary thereof;

The Council of the City of Litchfield, Minnesota ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.


Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatte land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof; Land in Meeker County, Minnesota to wit:

The West Half of the Northwest Quarter ($\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Eleven (11), Township One Hundred Nineteen, North (119-N), Range Thirty-one, West (31-W). Also that part of the SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 11, Township 119, Range 31 described in deed recorded in book 404 of deeds at pages 711-712.


Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with Minnesota Municipal Coordination, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.


