Ordinance No: 16 a-1744 bland ILLAGE OF ROCKFORD TO

AN ORDINANCI: OF THE VILLAGE OF ROCKFORD TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated the 7 day of December, 1969, requesting innexation of the territory hereinafter described was duly presented to the council on the 15 day of December, 1969; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 66.5 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the town board and the county board have filed a waiver of any objections to annexation proceedings; and WHEREAS, the land described in the petition abuts upon the village limits at the northern boundary thereof; and

The council of the Village of Rockford, Minnesota, ordains: Section 1. The village council hereby determines (1)

that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

That part of the West half of the Southwest quarter of Section 29, Township 119 North, Range 24 West, Wright County, Minnesota lying Northerly of the Crow River and lying Southerly of the line 33 feet Northwesterly of and parallel with the center line of the township road as now laid out and travelled.

And that part of the Southeast quarter of the Southwest quarter of Section 29, Township 119 North, Range 24 West, Wright County, Minnesota lying Northwesterly of the Crow River.

And that part of the East half of the East half of the Southeast quarter of Section 30, Township 119 North, Range 24 West, Wright County, Minnesota lying Northerly of the Crow River and lying Southeasterly of a line 33 feet Northwesterly of and parallel with the township road as now laid out and travelled except the Westerly 242 feet thereof.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Hinicipal Commission, the Secretary of State, and the County Aulitor.

Section 4. Effective Date. This ordinance takes effect its passage and publication.
