ORDINANCE NUMBER 115 VILLAGE OF FOLEY BENTON COUNTY MINNESOTA

WHEREAS, Ordinance Number 114 of the Village of Foley, County of Benton and State of Minnesota, which ordinance annexes certain property into the Village of Foley, Minnesota, contains an incorrect description of the real estate,

THE COUNCIL OF THE VILLAGE OF FOLEY MINNESOTA, ORDAINS AS FOLLOWS:

THAT Section 100:04(2) of Ordinance Number 114 of the Village of Foley, County of Benton and State of Minresota, be amended to read as follows:

Section 100:04(2) TERRITORY ANNEXED. The Corporate Limits of the Village of Foley are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

The South Half and the West Half of the North Half (S½ and W½ of N½) of Lot Ten (10) of Auditor's Subdivision of the Southeast Quarter of Southwest Quarter (SE½ of SW½), of Section Twenty-six (26), Township Thirty-seven (37), Range Twenty-nine (23), Denton County, Minnesota;

AND

That portion of First Avenue West abutting upon the above described premises.

Passed and adopted at the Regular meeting of the Village Council on the 3rd day of March, 1970 by unanimous vote of all members present.
