ORDINANCE NO. 1567

(N ORDINANCE Annexing to the City of Rochester, Minnesota, Certain Unplatted Land not Exceeding 200 Acres in Area, all Being in the East Half of Section 16, Township 106 North, Range 14 West, Olmsted County, Minnesota.

THE COMMON COUNCIL OF THE CITY IF ROCHESTER DO ORDAINS.

Section 1. A patition, has been tiled with the Common Council of the City of Achester, Signed by all of the owners of he land described herein, requesting the common Council to annex said land to the City of Rochester, The land described in Said petition for annexation is located in Rochester Township, Olmsted County, Minnesota, and is described as follows:

That part of Section 10, Township 106 North, Range 14 West, described as follows; all that part of the North west Quarter of the Southeast Quarter lying Westerly of the West right and Easterly of the Southeast Quarter, and Easterly of the Southeast Quarter, and all that part of the Southeast Quarter, and westerly of the Southeast Quarter of the North Southeast Quarter of the North Southeast Quarter, and westerly of the West right-of-way line of Sixteenth Street Southwest Quarter of the Northeast Quarter of the Northeast Quarter, and westerly of the West right-of-way line of T.H. No. 52, and all that part of the Southeast Quarter of the Northeast Quarter of the No

by said Town Board.

Section 2. The quantity of land included in said petition is approximately 110° acres.

Section 3. The Common Council of the City of Rochester does hereby determine that the land described in Section 1 abuts upon the present territorial limits of the City of Rochester, is so conditioned as to be properly subjected to municipal government, and the annexation of said land will be in the best interest of the City of Rochester and of the land affected.

Section 4. The land described in Section 1 above is hereby annexed, added fo and made a part of the City of Rochester, Minnesofa, as effectually as if it had originally been a part thereof.

Section 5. Present and tuture owners of the area annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the Intention of the Common Council to assess against benefited property all or a portion of the cost of any storm sewer, water tower and trunk line, sanitary sewer construction, hereforce or hereafter, undertaken to serve the area annexed.

Section 6, Present and tuture owners of the area annexed by this ordinance are hereby notified that by such annexation, the City of Rochester does not commit ifferent the serve annexed seven in service and make local improvements in the area annexed; and that the City of Rochester and extend City services and make local improvements to seven the later annexed areas in hereby annexed if the some appears more reasonable and economical.

Section 7. This ordinance shall take effect and be in force from and after the filling of a certified copy hereby with the Minnesofa Municipal Commission, the Rochester Town Cierk, the County Auditor and the Secretary of State.
