

ORDINANCE NO. 74

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN LAND TO THE VILLAGE OF HARMONY, MINNESOTA AND THE EXTENSION OF THE CORPORATE LIMITS THEREOF

The Village Council of the Village of Harmony, Minnesota do ordain as follows:

SECTION I - That the petition of William Kiehne Sr., William Kiehne Jr., A. Andrew Overby, Robert Peters, Howard Wickett, and Lois Wickett, as administratrix of the estate of Donald Wickett, and the Village of Harmony, all of the owners of the following described tract of land located in the County of Fillmore and State of Minnesota, to-wit:

The East thirty (30) acres of the Northeast Quarter of the Southeast Quarter (NE, SE_{1/4}), Section Ten (10), Township One Hundred one (101), Range Ten (10), and commencing at the Southwest (SW) corner of the Northwest Quarter of the Southwest Quarter (NW, SW_{1/4}), Section Eleven (11), Township One Hundred One (101), Range Ten (10), thence North 417 feet, thence East 288 feet, thence South 417 feet, thence West 288 feet to point of beginning, subject to highway and power line easements of record,

has been duly presented to this Council.

SECTION II - That said tract of land being unplatteed, less than 200 acres in area and abutting upon the corporate limits of said Village of Harmony, Fillmore County, Minnesota, is a proper subject for Village Government by said Village of Harmony, Minnesota.

SECTION III - That it would be to the best interests of the Village of Harmony, Minnesota, and the territory affected to annex said tract of land to said Village of Harmony, Minnesota.

SECTION IV - That said tract of land be, and it hereby is,

annexed to said Village of Harmony, Minnesota, and that the corporate limits of said Village of Harmony, Minnesota, are hereby extended to include said tract of land.
