

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES ABUTTING THE CITY LIMITS.

WHEREAS, a Petition was filed requesting the annexation of the territory hereinafter described, which Petition was duly presented to the Common Council on the 1st day of November, 1970, and

WHEREAS, the quantity of lands embraced within the brea described in the Patition and bounded as described is 1.235 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHENEAS, the Petition was signed by all the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be ammered; and

WHEREAS, the land described in the Patition obuts upon the City of Austin at the North boundary thereof:

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1) The City Council hereby determines, 1) that the emeration will be to the best interests of the City and of the territory effected, 2) that the territory described herein obute the city limits, and is about to become urban or suburban in character, and 3) that more of said territory is now included within the limits of any city, village or borough.

SECTION 2) The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the City of Austin as effectually as if it had originally been a part thereof:

Commencing at the Southeast corner of the NEW NWW of Section 4. Township 102 North, Range 18 West, Mower County, Minnesota, thence 330.24 feet west on 1/18 line of said NWs; thence 507.35 feet north at a deflection angle of 50047' right, on wast line of outlot 12 of said NEW of the NW as described on Page 33. Book 4, of Plate in the Mover County Register of Deeds Office, which point hereinafter shall be called the point of beginning; thence costerly along the north line of Block 1, McCourt Subdivision to the City of Austin, Minnesots, a distance of 321.87 feet to the west line of Lot 5, Block 2, Mouer Addition to the City of Austin, Minnesota, thence north 167.0 feet along the extension of the west line of said Lot 5 to the centerline of 6th Ave. N. W., thence westerly along the conterline of said 6th Ave. N. W. to a point that is 33 feet north and 83 feet west of the northeast corner of outlot 11 os described on Page 33, Book 4 of Plats in the Mower County Rogister of Daeds Office, thence south 167.0 feet to the northwest corner of Lot 1, Black 1, of said McCourt Subdivision, thomas casterly slong the north line of said McCourt Subdivision to the point of beginning.

SECTION 3) The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Township Clerk of Austin Township.

SECTION 4) The Ordinance takes affect upon its passage and publication and filing of the certified copies as directed in Section 3.
