

AN ORDINANCE EXTENDING THE CORPORATE
LIMITS OF THE CITY OF MANKATO TO
INCLUDE CERTAIN UNINCORPORATED UNPLATTED
LAND NOT EXCEEDING TWO HUNDRED ACRES
ABUTTING UPON THE CITY LIMITS.

WHEREAS, a petition has been duly filed and presented to the Council, requesting annexation of the territory hereinafter described; and

WHEREAS, the quantity of the land embraced within the area described in the petition does not exceed 200 acres, and abuts upon the City Limits at the easterly boundary thereof, no part of which is included within the limits of an incorporated, city, village, or burough; and

WHEREAS, the petition was signed by the owners, Independent School District #77, and

The City of Mankato, Minnesota, does ordain:

1. That the annexation will be to the best interests of the City and of the land affected;
2. That the land described herein abuts upon the City limits and is urban in character; and
3. That none of said land is now included within the limits of any city, village, or burough.

The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

a. The east 38 acres of the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 16, Township 108, Range 26.

b. All that part of the northwest quarter of the southeast quarter of Section 16, Township 108 north, Range 26 west, containing 13.2 acres more or less and described as follows:

Beginning at the center of said Section 16, thence north 90° -00' east on an assumed bearing, along the north line of said northwest quarter of the southeast quarter 440.00 feet to the southeast corner of Lot 3 of Block 3 of Kenwood Heights Addition to the City of Mankato, Minnesota; thence south 0° -00', 1313.05 feet, to the south line of said northwest quarter of the southeast quarter, thence north 89° -48' west, along said south line of the northwest quarter of the southeast quarter, 433.25 feet to the southwest corner of said northwest quarter of the southeast quarter, thence north 0° -17.7' west, along the west line of said northwest quarter of the southeast quarter, 1311.55 feet to the place of beginning.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor. This Ordinance shall take effect ten days after the date of its passage and publication.
