AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF MARSHALL.

The Common Council of the City of Marshall do ordain as follows:

Section 1. The parcels of real estate hereinafter described which are owned by the City of Marshall and which abut on the corporate limits thereof, are hereby annexed to said City.

Section 2. Said real estate so annexed is located in the County of Lyon, State of Minnesota and is described as follows, to-wit:

All that part of the North Half of the Northeast Quarter (N2NE4) of Section 33, in Township 112 North, of Range 41, West of the Fifth Principal Meridian, lying northwesterly and westerly of the public highway as the same is now located over and across said land, excepting that portion lying northwesterly of the southeasterly line of the right-of-way of the Great Northern Railroad, containing 39.5 acres more or less.

Also all that part of the Southwest Quarter of the Northeast Quarter (SW\(\frac{1}{4}\)NE\(\frac{1}{4}\)) and of the Northwest Quarter of the Southeast Quarter (NW\(\frac{1}{4}\)SE\(\frac{1}{4}\)) of Section 33, in Township 112 North, of Range 41, West of the Fifth Principal Meridian, lying westerly and northwesterly of the public highway as the same is now located over and across said land, containing 25.7 acres, more or less. Also all that part of the East Half of the Northwest Quarter (E\(\frac{1}{2}\)NW\(\frac{1}{4}\)) of Section 33, in Township 112 North, of Range 41, West of the Fifth Principal Meridian, lying east and south of the Great Northern Railroad right-of-way, containing 16.4 acres, more or less.

Southeast Quarter (SE+) and the South Half of the Southwest Quarter (S2SW+) of Section 28, Township 112, Range 41 West of the Fifth Principal Meridian (subject to railway right-of way and subject to highway easements), containing approximately 232.11 acres, more or less.

Northeast Quarter of Southwest Quarter (NE4SW4) of Section 28, Township 112 North of Range 41 West of the Fifth Principal Meridian, subject to easements of record or otherwise.

All that part of the North Half of Section 33, Township 112
North, Range 41 west described as follows: Beginning at a
point where the north section line of said Section 33 intersects
the northwesterly right-of-way line of the Willmar & Sioux Falls
Railroad located and constructed through said Section 33, thence
southwesterly along said right-of-way line on an assumed bearing
of south 19 degrees 50 minutes west 363.1 feet, thence north 89
degrees 48 minutes west 1311.1 feet, thence north 0 degrees 01 minutes
east 331 feet, thence north 89 degrees 44 minutes east 1437 feet to
point of beginning, containing 11.54 acres more or less.

Section 3. This ordinance shall take effect from and after its adoption and publication, and from and after a certified copy thereof has been filed with the Minnesota Municipal Commission, the Town Clerk of Fairview. "I Township, the County Auditor of Lyon County and the Secretary of State.
