## ORDINANCE NO. 452

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN TRACTS OR PARCELS OF LAND WHICH ARE BORDERED AT LEAST 60% BY THE MUNICIPALITY.

The Common Council of the City of Marshall do ordain as follows:

OIL IX

Section 1. The Common Council of the City of Marshall hereby determines and finds that the perimeter of the tract or parcel of land hereinafter described is bordered more than 60% by the City of Marshall, that the same is urban in character and is so conditioned as properly to be subject to city government.

Section 2. The corporate limits of said City are hereby extended to include the tract or parcel of land described as follows and the same is hereby annexed to and included within the City as effectually as if it had been originally a part thereof:

All that part of the Northwest quarter of the Southwest quarter (NW15W2) of Section 3, Township 111 North, Range 41 West, in Lyon County, Minnesota, described as follows:

Beginning at a point 33 feet east of the west section line of Section 3, Township 111 North, Range 41 West and 225 feet south of the center line of Trunk Highway No. 19 as now laid out and constructed; thence easterly and parallel with the center line of said Trunk Highway 772 feet, thence south 65 feet, thence easterly and parallel with the center line of said Trunk Highway 350 feet, thence north 65 feet, thence easterly and parallel with the center line of said Trunk Highway 208.74 feet to the northsouth 1/16 line, thence south on the 1/16 line 1100.06 feet to the east-west 1/16 line, thence west on the east-west 1/16 line approximately 1294.72 feet to a point 33 feet east of the west section line, thence north and parallel with the west section line approximately 1101.08 feet to the point of beginning.

Section 3. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the Town Clerk of Lake Marshall Township, the County Auditor of Lyon County and the Secretary of State and from and after its passage and publication.
