### ORDINANCE NO. 389

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO
THE CITY OF WASECA, MINNESOTA, AND ESTABLISHING THE ZONING THEREOF:

WHEREAS, the land hereinafter described is unplatted land of less than 200 acres situated in Woodville Township, Waseca County, Minnesota, and abuts upon the corporate boundary of the City of Waseca within the meaning of Minnesota Statutes Section 414.011, Chapter 1146 Laws of 1969; and

WHEREAS, all of the owners of said land have petitioned the Council of the City of Waseca to have the land hereinafter described annexed to and included within the abutting City of Waseca; and

WHEREAS, Notice of Intent to Annex the hereinafter described land has been served upon the Town Board of Woodville Township, that sixty (60) days have passed since such service of Notice of Intent to Annex, and that no objection thereto have been forthcoming; and

WHEREAS, the Council of the City of Waseca has determined that the annexation of said land to said City will be to the best interests of said City and of the territory affected;

NOW, THEREFORE, pursuant to the provisions of Minnesota Statutes Section 414.033, Subdivision 5, Chapter 1146 Laws of 1969:

THE CITY OF WASECA DOES ORDAIN:

## SECTION I.

That there is hereby annexed to and included within the City of Waseca, Minnesota, the following described land in the County of Waseca and State of Minnesota, to-wit:

Beginning at a point 1322 feet North of the Quarter post on the East line of Section 7, Township 107 North, Range 22 West, thence running West  $214\frac{1}{2}$  feet; thence South at right angles 203 feet; thence East at right angles  $214\frac{1}{2}$  feet; thence North at right angles 203 feet to the point of beginning.

### SECTION II.

That said land is hereby zoned Residential within the meaning of the Zoning Ordinance of Waseca.

### SECTION III.

That a copy of this ordinance shall be filed with the Minnesota Municipal Commission, the Clerk of the Woodville Township Board, the Auditor and the Register of Deeds of the County of Waseca, and the Secretary of the State of Minnesota.

#### SECTION IV.

That this Ordinance shall be effective ten (10) days after its adoption and publication as provided by law.
