ORDINANCE NO. 164

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LANDS.

The City Council of the City of Worthington Do Ordain:

Section 1. Petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following real estate, to have such property included within the City of Worthington, Minnesota:

Commencing at the Southwest corner of Lot 1, Block 2, of Auditor's Plat of Sungold Heights in the Southeast Quarter (SE_{1/4}) of Section 13, Township 102, Range 40, as the place of beginning; thence due north along the west line of Blocks 2 and 3 and the Northerly extension thereof in said Auditor's Plat of Sungold Heights (being the East line of Spring Avenue and the Northerly extension thereof), a distance of 793.19 feet to a point on the South line of the Easterly extension of Cecilia Street produced East from Watland's First Addition to the City of Worthington; thence North 89 degrees 46 minutes 30 seconds East along the extended South line of Cecilia Street produced Easterly of said Watland's First Addition to the City of Worthington, to the east line of said Section 13, a distance of 1298.35 feet, more or less; thence South on the East line of said Section 13 to a point on the North line of Service Drive extended Easterly, in said Auditor's Plat of Sungold Heights a distance of 699 feet, more or less, thence Westerly on the North line and extended North line of Service Drive in said Auditor's Plat of Sungold Heights to the place of beginning, a distance of 1320.33 feet, more or less; excepting therefrom Lots 8 and 9, Block 1, in said Sungold Heights Subdivision. Subject to any existing easements, covenants and restrictions and subject to road right-of-way.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 22.01 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on September 15, 1970, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the City are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon filing of the certified copies as directed in Section 6.
