AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF  
THIEF RIVER FALLS

The City Council of the City of Thief River Falls do  
hereby ordain as follows:

Section 1.

WHEREAS the sole owner of the following described premises  
situated in the Township of North, County of Pennington and  
State of Minnesota, to-wit:

A parcel of land which is a portion of Noper's Second  
Addition to Thief River Falls and portions of the North-  
east Quarter of the Northeast Quarter ( $NE\frac{1}{4}NE\frac{1}{4}$ ), Southeast  
Quarter of the Northeast Quarter ( $SE\frac{1}{4}NE\frac{1}{4}$ ) and Northeast  
Quarter of the Southeast Quarter ( $NE\frac{1}{4}SE\frac{1}{4}$ ), Section Thirty-  
two (32), Township One Hundred Fifty-four (154) North,  
Range Forty-three (43) West bounded as follows:

Beginning at the point of intersection of the East line  
of said Section Thirty-two (32) and the South line of First  
Street; thence South along said East line a distance of  
1240'; thence West a distance of 1020'; thence North along  
a line parallel to and 1020' West of said East line of  
Section Thirty-two (32) to an intersection with the  
southerly line of said Noper's Second Addition; thence  
Northwesterly along said southerly line to the southwest  
corner of Lot Three (3), Block Three (3) of Noper's Second  
Addition; thence Northeasterly along the westerly line of  
said Lot Three (3) extended to an intersection with the  
centerline of Minnesota Trunk Highways #1 and #59; thence  
southeasterly along said Highway centerline to the east  
line of said Section Thirty-two (32); thence South along  
said Section line to the point of beginning; containing  
Fifty-nine (59) acres more or less.

This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Commission, Town Clerk, the Pennington County Auditor and the Secretary of State of the State of Minnesota.

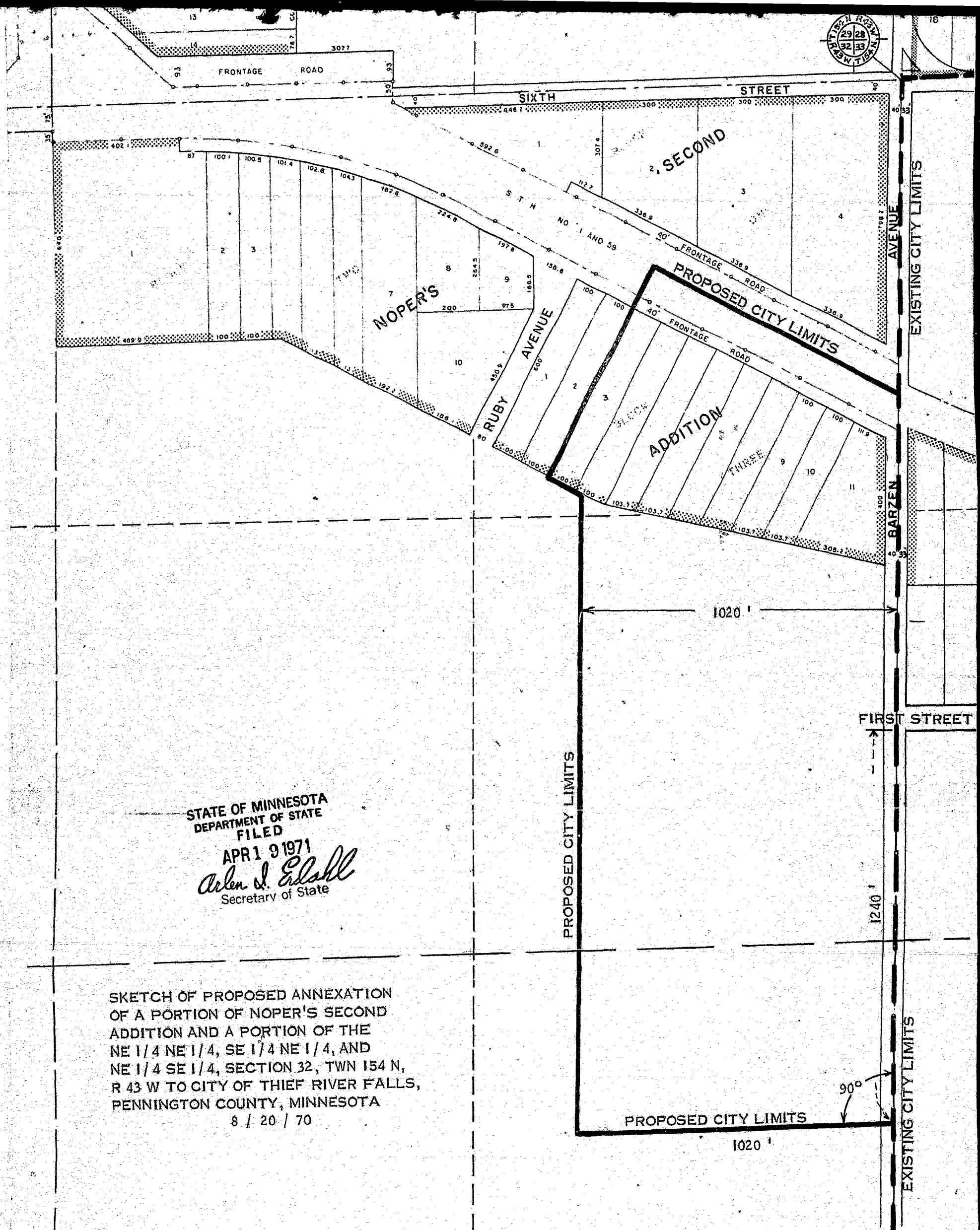
