NOW, THEREFORE, I, WENDELL R. ANDERSON, AS GOVERNOR OF THE STATE OF MINNESOTA, acting under the authority and direction of Minnesota Constitution Art. IV Sec. 17 and Minnesota Statutes Sec. 203.45 to 203.56 and other relevant statutes do hereby direct:

- (1) that a special election to fill the vacancy be held in Legislative District 2B on Tuesday, the 4th day of May, 1971;
- (2) that a special primary election for the nomination of candidates for the office be there held on Tuesday, the 20th day of April, 1971;
- (3) that affidavits of candidacy must be duly filed on or before Tuesday, the 13th day of April, 1971;
- (4) that the notices of this special election and special primary election, the nomination and election of candidates, and the conduct of these elections be had and all things pertaining thereto be done as provided by Minn. Stat. 1969 Sections 203.44 to 203.55 and other applicable provisions of law.
