ORDINANCE NO. L3L

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LANDS.

The City Council of the City of Worthington Do Ordain:

Section 1. Petitions have been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following real estate, except the City of Worthington, to have such property included within the City of Worthington, Minnesota; and whereas, the City of Worthington owns a portion of said property which is situated outside of, but contiguous to, and abutting on the corporate limits of the City, and the City Council has determined to have such land also included within the City of Worthington:

Lots 8 and 9, Auditor's Outlots 1 to 12, Section 14, Township 102, Range 40, Nobles County, Minnesota.

Part of Lot 7 of Auditor's Outlots 1 to 12 in the South One-Half (S2) of Section 14, Township 102, Range 40, described as follows: Beginning at the Southeast corner of Lot 7 and thence North along the East line thereof a distance of 110 feet, which point is the place of beginning; thence North along the East line of said Lot 7 to the Northeast corner thereof; thence West on the North line of said Lot 7 a distance of 139.25 feet; thence at right angles Southeasterly and parallel to the East line of said Lot 7 to a point opposite the point of beginning; thence at right angles Easterly a distance of 139.25 feet, more or less, to the place of beginning, and

Tract III;
All that portion of the Southwest Quarter (SWM) of Section 14,
Township 102, Range 40, lying West of the Rock Island Railway right-ofway and South of Interstate Highway No. 90, except the following
described tracts described on the Eldon Rowe Survey, dated April 20,
1956, as follows:

Tract "D" owned by Keith S. Nerem and Vernon D. Suby as shown in a Warranty Deed dated January 26, 1967, and recorded February 7, 1967, in the office of the Register of Deeds, Nobles County, Minnesota, as Document Number 172456.

Tract "E" owned by H. J. Koob and Q. P. Koob as shown in a Warranty Deed dated March 31, 195h, and recorded April 1, 195h, in the office of the Register of Deeds, Nobles County, Minnesota, Book 100, Page 87 of deeds.

Tract "G" owned by Vincent T. Greelis as shown in a Warranty Deed dated August 19, 1963, and recorded October 2, 1963, in the office of the Register of Deeds, Nobles County, Minnesota, as Document Number 163704.

A tract of land in Tract "J" 150 feet by 360.74 feet owned by Arthur Schaap and Larraine W. Schaap as shown in a Warranty Deed dated May 18, 1965, and recorded May 28, 1965, in the office of the Register of Deeds, Nobles County, Minnesota, as Document Number 168127.

and also excepting any property previously annexed to the City of Worthington

Rage :2 .- Ordinance No. 434

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 39.67 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on May 13, 1969, that said matter was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the bests interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the City are hereby extended to include the property described in Section 1, and that the same is hereby sunexed to, and included in the City of Worthington as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
