Ordinance No. 232
of the City of St. Paul, Minnesota
relating to the annexation of certain
land

The City Council of the City of St. Paul, Minnesota, do hereby ordain as follows:

Section 1. The following described parcels of land are wholly within the city limits and are non-agricultural and are suitable for urban purposes:

The southeast quarter of the southeast quarter (1/4 of 1/4) of section one (1) in Township one hundred thirty-three (133) North of Range thirty-three (33) East,

part of the Northeast quarter of the Southeast quarter (1/4 of 1/4) of section one (1), Township one hundred thirty-three (133) North of Range thirty-three (33) East described as follows: commencing at the northeast corner of the Northeast quarter of the Southeast quarter (1/4 of 1/4) of section one (1), thence running east 79 feet; thence running south 79 degrees, 7 minutes east 897 feet to a point on the east line of said Northeast quarter of Southeast quarter (1/4 of 1/4) of section one (1), Township one hundred thirty-three (133) North of Range thirty-three (33), 747 feet south of the point of beginning; thence north 747 feet to the point of beginning.

Section 2. The quantity of land embraced within the foregoing parcels is bounded as described is approximately 40.67 acres and abuts on the present city limits along the west line of said tract.

Section 3. The City Council now advises that the annexation will be to the best interests of the City of St. Paul, Minnesota and of the property affected and is so considered as properly to be subject to city government and is authorized by Minnesota Statutes 414.03, subdivision 2.

Section 4. Therefore, the City of St. Paul hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of St. Paul, as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall be in effect and be in force from and after the filing of certified copies thereof with the Minnesota Land Office, the County Auditor, the Secretary of State of Minnesota, the State Register of Deeds and, from and after its passage and publication.
