## CHAPTER XV

## ORDINANCE NO. 150 - R

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED ON THREE SIDES BY SIXTY PERCENT, OR MORE, BY LAND WITHIN THE VILLAGE LIMITS AND ABUTTING THEREON.

WHEREAS, cortain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and, WHEREAS this territory is sixty percent, or more, bordered on three eldes by lands already included within the corporate limits of the Village and is deemed to be urban in character; and,

WHEREAS, A Notice of Intent to annex said lands was served upon the Town Board of Lo Sauk Township on the leth day of October, 1970, by said Village of Sartells and, WHEREAS the said Town Board of Lo Sauk Township did on the 11th day of December, 1970, file objections to said annexation, by said Village of Sartell, with the Minnesota Municipal Commissions and,

WHEREAS, pursuant to said filing of objections the Minnesota Municipal Commission did issue its order for a hearing on said annexation which public hearing was scheduled for the 7th day of April, 1971, at 10:00 o'clock A. M., which Notice was duly published in the 5t. Cloud Daily Times, a legal newspapers and, WHEREAS, the said Town of Le Sauk did on the 1st day of April, 1971, withdraw said objections as filed by it and also filed a notice of no appearance in said matter and withdraw all opposition to the annexation of the territory described below; and WHEREAS, said Minnesota Municipal Commission did cancell said public hearing;

THE VILLAGE COUNCIL OF SARTELL, MINNESOTA, ORDAINS AS FOLLOWS:

## Section 1. Territory Annoued.

The corporate limits of the Village of Sartell, Minnesota, are hereby extended to include the platted and unplatted lands described below, which territory now is, and has heretofore been, sixty percent or more bordered on three sides by territory already included within the Village Limits of Sartell, Minnesota, to-wit:

## LEGAL DESCRIPTION OF TERRITORY BEING ANNEXED

"Commencing at the Northeast corner of the Northeast Cuarter of Southwest Cuarter (NE) SNE) of Section 16, Township 125 North, Range 28, Stearns County, Minnesotal thenco West along North line thereof a distance of 726.03 feets thence South at right angles, along Villago Limits, a distance of 292-4 feets thance West and parallel with North line of said Quarter a distance of 80-13 feet; thence South at right angles a distance of 1027.31 feet to South line of sold NET SWE of said Scotlon 168 thence West along South line of said NE? SNY to the Southwest corner thereoff thence South on West Line of Southeast Quarter of Southwest Quarter (SEE SWE) of Soction 16 to South line of Section 16; thence East on South line of Section 16 to center of Minesceippi River to point of intersection with Villago Limites thence Northerly along the center line of Mississippi River and the Westerly Boundary line of the Village Limits in Benton County, Minnesota, to the point of intersection of the North Line of Government Lot 3, extended East, of Section 16, which is the center line of Section is extended Easty thence West along said North line of Government Lot 3 as extended East and continuing along said line to the Northeast corner of the Northeast Quarter of Southwest Quarter (NE; SN;) of said Section 16 to the point of beginning, less that part heretofore armexed to the Village, described as follower

"A tract of land lying in and being a part of Government Lot 4, Section 16, Township 125, Range 26, as follows: Beginning at the Southeast corner of sald Government Lot 5, Section 16, thence due West along the South line of said Government Lat 4 to a point of intersection with Easterly right of way line of State Highway No. 1; thouco Mortherly slong said Easterly right of way line of gaid road to a point 33 feet due North of South line of Covernmont Lot 49 thence due West and parallel with South line of Government Lot A to a point of intersection with Easterly Line of Alley now existent in Block 2 of Portiol re-arrangement of the Village of Sartell extended Northexly; thence Northerly and parallel with the Shoterly right of way line of S.A.R. No. 1 for a dictance of 132 feets themse due East and parallel with said South line of Government Lot 4 to a point on the Westerly Bank of Mississippi River; thence Southerly along said Westerly Bank of said River to Southeast corner of Government Lot 4 to point of beginning. Also Out Lot No. 2 and all of that part of Out Lot No. 3 lying Southerly of a line described as follows: Commencing at the Southwest corner of Out Lot No. 1 and running thence in a Southwesterly direction across Out Lot No. 3 at right angles to the Westerly Boundary line of said Lout Lot No. 1, all in First Addition to Mississippi Drive, a platted subdivision in LeSauk Township, Steams County, Minnesota.

Said lands being ennexed to include all that part of the South Half (5 1/2) of Section Sixteen (16), Township One Hundred TwentyOFive (125) North, Range Twenty-Eight (28) hest, Stearns County, Minnesota, lying West of Center of Mississippi River, containing 177 acres, more or less, excepting that portion already annexed to the Village of Sartell, Minnesota.

### Soction 2. Filing.

The Village Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the Stearns County Auditor, Le Sauk Township and the Minnesota Municipal Commission.

#### Section 3. Effective Date of Annexation.

This Ordinance takes effect immediately upon its passage and publication and the filing of the certified copies as herein directed.

#### Zoning Classification. Section 4.

The territory herein being annexed is hereby annexed under Zoning Classification as R - 1.

Adopted by the Village Council of Sartell, Minnesota, by unamimous vote of the Council at regular meeting held on the 19th day of April, 1971.
