**ORDINANCE NO. 86**

The Council of the Village of Elk River, Minnesota, do ordain as follows:

SECTION 1. That the following described real estate situated in the County of Sherburne, State of Minnesota, and described as follows, to-wit:

- (a) The West 200 feet of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Thirty-five (35), Township 33, Range 26, lying South of County Road No. 12.
- (b) The Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section Two (2), Township 32, Range 26, except that part thereof that lies West of a line run parallel with and distant 200 feet Easterly of the West line of said Section Two (2) and Southerly of a line run parallel with and distant 100 feet Southerly of the North line of said Section Two (2); said exception containing 5.46 acres, more or less.
- (c) That part of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Thirty-five (35), Township 33, Range 26, lying South of County State Aid Highway No. 12; East of the West 200 feet thereof; and West of the following described line: Beginning at a point on the South line of said SW $\frac{1}{4}$  of SW $\frac{1}{4}$ , 675 feet West of the Southeast corner thereof; thence Northeasterly on a line running to a point on the center line of said highway which is 549.08 feet Northwesterly of the intersection of said center line and the East line of said SW $\frac{1}{4}$  of SW $\frac{1}{4}$ , to a point 300 feet Southwesterly of its intersection with said center line; thence Northwesterly parallel with said center line 300 feet; thence Northeasterly to a point on said center line which is 549.08 feet Northwesterly of the intersection of said center line and the East line of said SW $\frac{1}{4}$  of SW $\frac{1}{4}$ , and there terminating.

is hereby annexed to the Village of Elk River pursuant to the provisions of Chapter 414.033, Subdivision 5, of the Minnesota Statutes Annotated.

SECTION 2. This ordinance shall be effective October 15, 1970.
