ORDINANCE NO. 179

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WASHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED LANDS.

The City Council of the City of Washington do Ordain:

Section 1. Petition has been filed with the City Council of the City of Washington, Minnesota, signed by all of the owners in right of the following real estate, to have such property included within the City of Washington, Minnesota:

Spring Avenue running from the northerly boundary of Minnesota Highway No. 63 to the northerly boundary of Cassin Street extended easterly, in the Section 1, 2, 3, 4 and 5, Township 103N, Range 13E, Polk County, Minnesota.

Section 2. The quantity of land contained within the foregoing description, and bounded and described as follows:

Section 3. Notice was duly given the Board of Commissioners for Polk County and the Board of Commissioners for Washington Township on February 2, 1971, that said petition was being considered by the City Council of the City of Washington and a hearing was duly held by the City Council of the City of Washington, on the proposed ordinance after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the ordinance will be to the best interests of the City of Washington, Minnesota, and of the territory affected; (2) that the territory described herein does upon the City and do so conditional as property to be subjected to city government.

Section 5. The corporate limits of the City are hereby extended to include the property described in Section 1, and the area so hereby created to, and included in the City as effectively as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon filing of the certified copies as directed in Section 6.
