ORDINANCE NO. 590

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF RED WING TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ADJUTING UPON THE LIMITS OF THE CITY.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory abuts upon the corporate limits of the city at the south boundary thereof and is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the city;

The City Council of Red Wing ordains:

Section 1. Territory Annexed. The corporate limits of the city of Red Wing are hereby extended to include the unincorporated property described as follows now used by the city:

That part of Government Lot 4, Section 4, Township 112 North, Range 14 West, County of Goodhue, State of Minnesota described as follows:

Beginning at a point at the intersection of the north line of said Section 4 and the North-South center line of Section 6, thence North  $89^{\circ}51'30''$  West (assumed bearing) 447.25 feet along the north line of Section 6, thence North  $80^{\circ}40'15''$  West 523.60 feet along the north line of Section 6 to the southeastern right of way line of Twin Bluff Road, thence South  $42^{\circ}33'$  West along the southeastern right of way line of Twin Bluff Road 60.25 feet, thence easterly along a line which is parallel to and distance 50 feet from the north line of Section 6 to the north-south center line of Section 6, thence northerly 50 feet to the point of beginning.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.
