ORDINANCE NO. 106

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LAKEFIELD, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated February 10, 1971 requesting annexation of the territory hereinafter described was duly presented to the council on the 11th day of February, 1971; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 5 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all the owners; and

WHEREAS, no objections to the annexation have been received from the townboard, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, notice having been served upon said board's by mail on the 22nd day of February, 1971 and 60 days having elapsed thereafter exclusive of the day of service; and

WHEREAS, the land described in the petition abuts upon the Village of Lakefield limits at the East boundary thereof;

THE COUNCIL OF THE VILLAGE OF LAKEFIELD, MINNESOTA, ordains:

Section 1. The Village Council hereby determines (1) that the annexation will be to the best interests of the Village and of the territory affected; (2) that the territory described herein abuts upon the Village Limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory annexed. The corporate limits of the Village of Lakefield are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village of Lakefield as effectually as if it had originally been a part thereof and shall be known as O'Connor's Addition:

Commencing at a point 207.8 feet North of the Southwest corner of the Northwest Quarter of the Southwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section 33, Township 103 N, Range 36 W of the 5th P.M.; thence 737.2 feet North; thence 300 feet East; thence 390.8 feet South; thence 150 feet East; thence 346.4 feet South; thence 450 feet West to the point of beginning.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
