ORDINANCE NO. 26

An Ordinance relating to the annexation of certain property to the Village of Carlos, Minnesota, and extending the corporate limits to encompass said land.

WHEREAS, the Village of Carlos is the owner in fee of the hereinafter described property,

NOW THEREFORE, the Village Council of the Village of Carlos does ordain:

SECTION 1. That it is for the best interests of the municipality of the Village of Carlos and of the territory hereinafter described that such territory be annexed to and be made a part of the municipality of the Village of Carlos.

SECTION 2. That the following described land, to-wit:

The North Eleven Hundred Thirty-eight (1138.0) ft. of the East Seventy (70) acres of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Fourteen (14), Township One Hundred Twenty-nine (129) North, Range Thirty-seven (37) West of the 5th P.M., lying West of the right-of-way of the Minneapolis, St. Paul and Sault Ste. Marie Railway, and containing 26.90 acres more or less; And also a part of the said East 70 acres of the SE $\frac{1}{4}$  of Section 14, more particularly described as follows, to-wit: A strip of land being Forty (40.0) ft. wide and west of and adjacent to said Railway R/W, bounded on the south by the north line of County State Aid Highway No. 13, and on the north by the south line of the above described tract (the north 1138.0 ft. of the East 70 acres), and containing 1.40 acres; And in all containing 28.30 acres more or less,

is hereby annexed to and made a part of the municipality of the Village of Carlos, and the corporate limits of the Village of Carlos, Minnesota, shall be, and are hereby extended to include and encompass the lands and territories above described.

SECTION 3. All of said lands and territories described by limits, description and boundaries in Section 2 above are hereby annexed to and made a part of the Village of Carlos, Minnesota, and such land is deemed to be urban in character.

SECTION 4. This Ordinance shall take effect from and after its passage and publication in accordance with the laws of the State of Minnesota, and upon the filing of a copy of this Ordinance with the Municipal Commission of the State of Minnesota, the Clerk of the Township of Carlos, the County Auditor of Douglas County and the Secretary of State of the State of Minnesota.
