AN ORDINANCE RELATING TO THE ANNEXATION OF CERTAIN PROPERTY OF THE CITY OF ALEXANDRIA, MINNESOTA, DECLARING THE WARD TO WHICH IT SHALL BE ATTACHED, AND EXTENDING THE CORPORATE LIMITS TO ENCOMPASS THAT LAND.

WHEREAS, Project New Hope, Inc. has filed with the City Council a Petition alleging that it is the sole owner of the hereinafter described property, lying and being in the County of Douglas, State of Minnesota; That certain land abuts upon the corporate limits of the City of Alexandria; Is unplatted, does not exceed 200 hundred acres in area, is not homestead, and that no people reside in said territory, and

WHEREAS the governing body of the City of Alexandria has examined said Petition, determined the facts therein stated to be true; That the Petition was duly filed with the Minnesota Municipal Commission under and pursuant to Minnesota Statutes 414.033, there having been no objections filed with the Minnesota Municipal Commission to the annexation of said property; That the property is so situated as property to be subject to Municipal government, and that the annexation of said property would be for the best interest of the municipality and of the territory affected and to be annexed.

NOW THEREFORE: The City Council of the City of Alexandria does ordain:

SECTION I. That it is for the best interest of the municipality of the City of Alexandria, and of the territory herein described that said territory be annexed to and be made a part of the municipality of the City of Alexandria.

SECTION II. That the following described land, to-wit: The West $12\frac{1}{2}$ acres of the South one-half of the Southeast Quarter of the Northwest Quarter ($S\frac{1}{2}$ of $SE\frac{1}{4}$ $NW\frac{1}{4}$), Section 17, Township 128, Range 37, be, and is hereby annexed to and made a part of the municipality of the City of Alexandria, and the corporate limits of the City of Alexandria shall be, and hereby are extended to include and encompass the land and territory above described.

SECTION III. All of said land and territory described by limits and description and boundaries in Section II above, and hereby annexed to and made a part of the City of Alexandria, Minnesota, shall be and does hereby become a part of the Second Ward of the City of Alexandria.

SECTION IV. This ordinance shall take effect from and after its passage and publication in accordance with the laws of the State of Minnesota, the Charter of the City of Alexandria, and upon the filing of this Ordinance with the Municipal Commission of the State of Minnesota, the Town Clerk of Alexandria Township, the County Auditor of the County of Douglas, and the Secretary of State of the State of Minnesota.






